Financing

Donations are received from Individual Kiwanis Members and their Clubs in the three Districts across Canada. Gifts from corporations, other foundations and individuals are also gratefully received. All donations are used to carry out the Foundations Vision.

Agreement with the Kiwanis International Foundation

The Kiwanis Children's Fund has agreed that Annual donations and funds required for International Awards such as the Hixson/Zeller can be paid to the Canadian Foundation and retained in Canada for use in Kiwanis Children's Fund approved programs. Clubs and individuals receive full recognition from the Children's fund.



Programs Available to Assist You and Your Club

Organized Youth Grant Clubs may apply for a \$500 grant when they give \$1,000 to an organized youth group.

Send a Kid to Camp There is a 50% matching grant up to \$500 for youth requiring support. One grant per club per year.

Key Leader Grant When a youth is registered in a Key Leader Weekend the Foundation will donate \$50 toward each registrant.

Matching Scholarships Clubs may apply for a matching grant up to \$1,000 per year.

Mel Osborne Youth Scholarship For a Keyclub or Circle K student \$500 per year

New Club Building Grants Both SLP and Adult Clubs can obtain financial assistance when starting a new Club
