We are delighted to introduce two new members to the Board of Directors of the Kiwanis Foundation of Canada, Greg Holland and Jim Scott. Jim has served as president of the former London Kiwanis Club and more recently president of the Forest City-London Kiwanis Club. He is a former LG of Division 4, EC&C. Since joining Kiwanis he has been involved with the local Kiwanis Music Festival and has been Chair of the London Festival since 2000. After working with 3M for 33 years in Sales, Marketing and Human Resources, he



is now self employed in a 35-year family business that his wife Bev operates in London. They have 3 adult children.

Greg has been a Kiwanis member since 1999 and is a member of the Port Alberni club on Vancouver Island. He has served two terms as Lt. ### NEW FORMULAS FOR GROWTH

After considerable discussion and in the interest of playing an active role in the growth of Kiwanis membership, the Board of the Kiwanis Foundation of Canada has put into place two club building grants as an incentive formula for growth. These grants will be provided upon the Foundation receiving a copy of the signed completed documentation of the new Kiwanis Club charter.

For every new adult Kiwanis Club chartered in Canada with 15 new members, the Kiwanis Foundation of Canada will:

**Donate \$750** to the Sponsoring Kiwanis Club

**Donate \$750** to the newly Chartered Kiwanis Club

**Donate \$100** per member above Charter Membership

(as recorded at the start of the second year) to the newly Chartered Kiwanis Club

Existing Kiwanis Clubs, currently under Charter strength, that achieve Charter strength status by the end of this Kiwanis year, will receive \$100 for every new member up to a maximum of \$500. The grant payment will be provided once the final report is received from KI confirming the new club roster for the 2014-2015 Kiwanis year indicates a membership total of not less than 15 members.

Note: A new member is not a person who is already a member of another Kiwanis Club or transfers membership from another club.

## NEW MEMBER INCENTIVE CONTEST

Every Kiwanian who sponsors a new member and completes an application card will have a ballot placed in a draw.

FIRST PRIZE: The 2014 Kiwanis International Convention for the member and guest. Includes 2 tickets, return airfare and transfers from the nearest Canadian Gateway Airport, plus convention registration, 5 nights' accommodation (1 room each) at your International District Hotel in Tokyo/Chiba, Japan and \$1500 cash for other expenses.

**SECOND PRIZE:** The 2014 Kiwanis District Convention for the Sponsor and Guest. Includes convention registration, return transportation and four nights' accommodation (1 room each) at your District convention hotel.

Draw ends on March 31, 2014. Winners will be notified by telephone on April 15.

Note: Prizes are not transferable and hotel accommodation for both prizes provides one room for the Winner and one room for the Guest. Applications are available from your club secretary or on the Foundation website www.kfcdn.org Completed applications must be sent to the Foundation Office on or before March 31.

# HOW CAN YOUR CLUB BENEFIT FROM THE CANADIAN FOUNDATION?

- Award a \$500 Mel Osborne scholarship to an active member of your Key club at graduation no cost to your club.
- Recognize a non-Kiwanian in your community who is making a difference in the lives of those around you. For \$350 award a Mel Osborne shadow box. This recognition also helps increase the visibility of Kiwanis in your area.
- Your contribution to the Eliminate Project is increased by \$1 for every \$3 you donate.
- Develop a youth scholarship program in your club. If you meet the criteria, the KFC will increase your contribution by matching your scholarship up to \$1000 per club per year.
- When you build a new Service Leadership Program (K-Kids, Builders, Key Club, Aktion Club, Circle K) the KFC offers a grant of up to \$500 for the first club sponsored or 50% of costs up to \$500 for subsequent clubs.
- When you register any number of youth in a Key Leader weekend, the Foundation funds a \$50 subsidy for each registration.
- If your club makes a donation of at least \$1000 to a Youth Program such as Boys & Girls Club, Sea Cadets, Scout Groups, etc. the Foundation will give a Youth Development Grant of \$500 to the youth group to supplement your contribution.
- Every Kiwanian in your club who sponsors a new member before March 31, has the opportunity to enter the New Member Incentive draw.
- You can recognize a dedicated Kiwanian in your club, perhaps a past president, or one who has made valuable contributions to Kiwanis at the club, division and district levels. Award this person with a Mel Osborne Fellowship available from the KFC for a contribution of \$750.
- If you continue to support your Foundation with a minimum annual contribution of \$15 per member, you will be eligible for all benefits. This comes from your Service Account.
- Any individual who makes a donation through the KFC will receive a tax receipt.

## THE ELIMINATE PROJECT

At its semi-annual meeting during the International Convention in Vancouver, the Board of the Kiwanis Foundation of Canada voted unanimously to increase the Eliminate matching program from \$250,000 to \$500,000. That means that for every \$3 raised, the Foundation adds \$1 thus assisting Canadians in raising the first two million dollars toward the Eliminate Project goal in Canada. When all funds are matched, Kiwanis clubs in Canada will have saved and protected nearly 1,200,000 lives from maternal and neonatal tetanus.

#### MEL OSBORNE FELLOWS

It is indeed an honor to be inducted as a Mel Osborne Fellow. It signifies that you have been recognized by fellow Kiwanians as one who has made valuable contributions to our great organization; some at the club level, some at the division or district levels, or perhaps at all three. Some have been Mel Osborne fellows for many years. Others have joined our ranks just this year. Regardless of when one received the recognition, there is an expectation of all Mel Osborne fellows.

Each year the Foundation funds a number of Mel Osborne scholarships awarded to deserving young people who have been active members of a Key club or Circle K. In order for this program to be viable, it is expected that all Mel Osborne fellows donate \$150 annually so that the Foundation can continue to support our youth with their education. If in any year the stipulated amount is beyond your means, any contribution would be appreciated.

I, your editor, am a Mel Osborne Fellow and I again invite you to join me in making a significant contribution every year to our Foundation in support of the Mel Osborne scholarship program. Let us support the secondary education of our youth as our part of serving the children of the world.
